Monthly Executive Report as of February, 2024

I. Market Value as of February, 2024

The market value of the Pension Reserve Fund (PRF) totaled US\$ 9,596.30 million at the end of the month. The variation was due to: (i) accrued interests of US\$ 20.91 million; (ii) capital gains on investments of US\$ 49.40 million; and (iii) administrative, custody and others costs of US\$ 0.62 million.

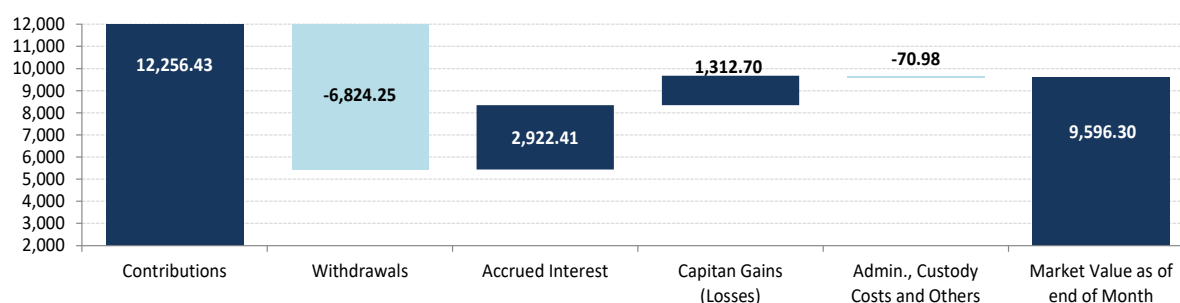

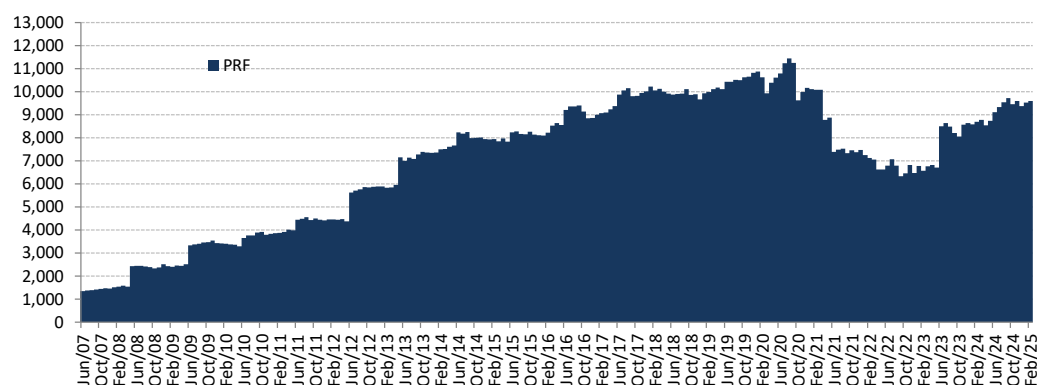

II. Return as of February

The net return in US dollars was 0.73% in the month. The portfolio return is broken down into the return of the Sovereign and Government Related Bonds, 1.26%, Inflation-Linked Sovereign Bonds, 1.35%, US Agency MBS, 2.47%, Corporate Bonds, 1.64%, High Yield Bonds, 0.70%, and Equities, -0.59%. The monthly return of the total fund in pesos was -3.03%. The fund's accumulated return for the year was 2.33% in US dollars and -1.89% in pesos, while the annualized return since inception was 3.41% in US dollars and 6.74% in pesos.

Returns for periods of more than one year are compound annualized rates while those for less than a year correspond to the change as seen in the stated period. With a view to meeting high standards of transparency and providing a better assessment of the gains or losses on investments, the Ministry of Finance discloses the fund's return in different time horizons and currencies. With respect to the horizon, it is important to note that, in keeping with the medium- and long-term investment policy, the return assessment should focus on that period, disregarding fluctuations that may occur monthly or quarterly. With regard to returns expressed in different currencies, the return in US dollars allows for an assessment which is more in line with the investment policy given that the fund's resources are wholly invested abroad and in foreign currency. The return in Chilean pesos is also disclosed. This return reflects changes in the peso-dollar exchange rate and, therefore, may experience greater fluctuations. Finally, as with any investment, returns obtained in the past do not guarantee future positive results.
