Monthly Executive Report as of July 2011

I. Market Value as of July, 2011

The market value of the Pension Reserve Fund (PRF) totaled US\$4,491.42 million as of July, 2011. The market value changed during this month due to: (i) accrued interest of US\$6.95 million, (ii) capital gain on investments of US\$40.17 million, and (iii) administrative, custody, and other costs of US\$0.02 millions.

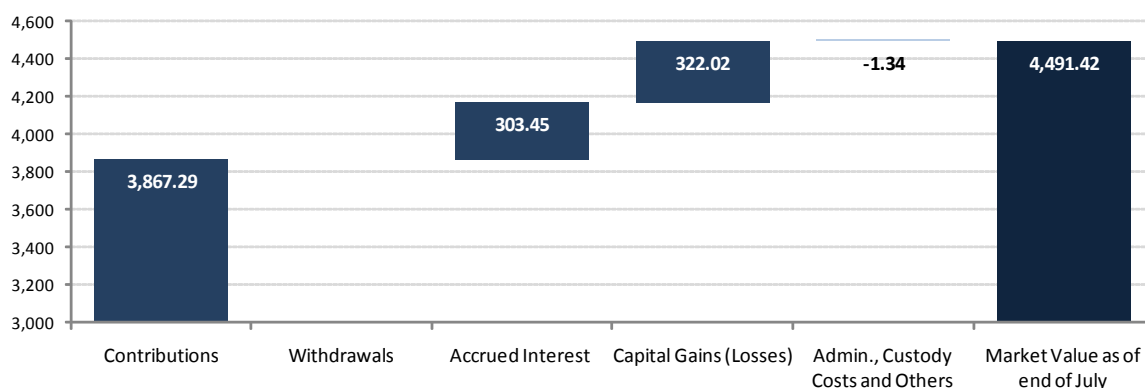

Changes in Market Value Since Inception

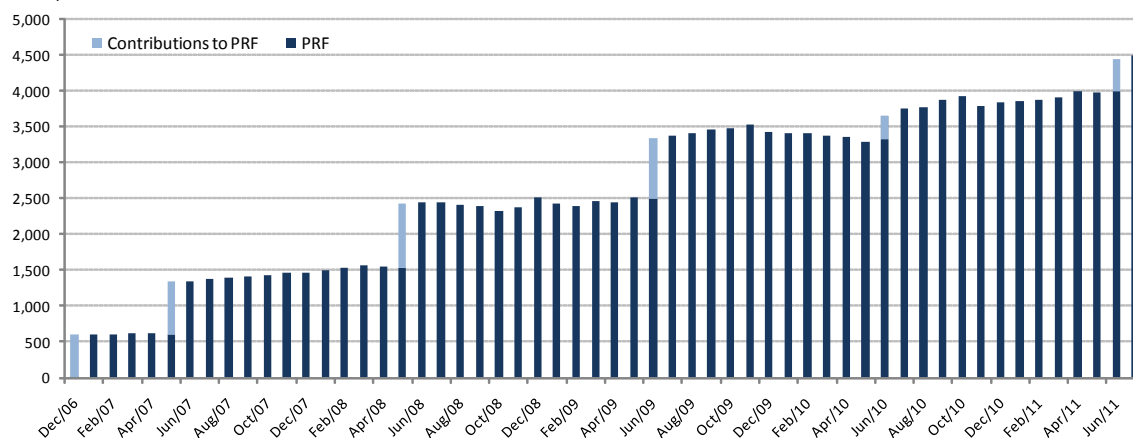

II. Return as of July, 2011

Return in July was 1.06% in US dollars and -2.17% in Chilean pesos. Cumulative return in 2011 totaled 5.44% in US dollars and 2.78% in Chilean pesos. Annualized return since inception was 5.97% in US dollars and 2.17% in Chilean pesos.

(c) Return in CLP corresponds to the sum of the percentage change of the exchange rate CLP/USD and the return in USD.

Returns for periods of more than one year are compound annualized rates while those for less than a year correspond to the change as seen in the stated period. With a view to meeting high standards of transparency and providing a better assessment of the gains or losses on investments, the Ministry of Finance discloses the fund's return in different time horizons and currencies. With respect to the horizon, it is important to note that, in keeping with the medium- and long-term investment policy, the return assessment should focus on that period, disregarding fluctuations that may occur monthly or quarterly. With regard to returns expressed in different currencies, the return in US dollars allows for an assessment which is more in line with the investment policy given that the fund's resources are wholly invested abroad and in foreign currency. The return in Chilean pesos is also disclosed. This return reflects changes in the peso-dollar exchange rate and, therefore, may experience greater fluctuations. Finally, as with any investment, returns obtained in the past do not guarantee future positive results.
