I. Market Value as of January, 2019

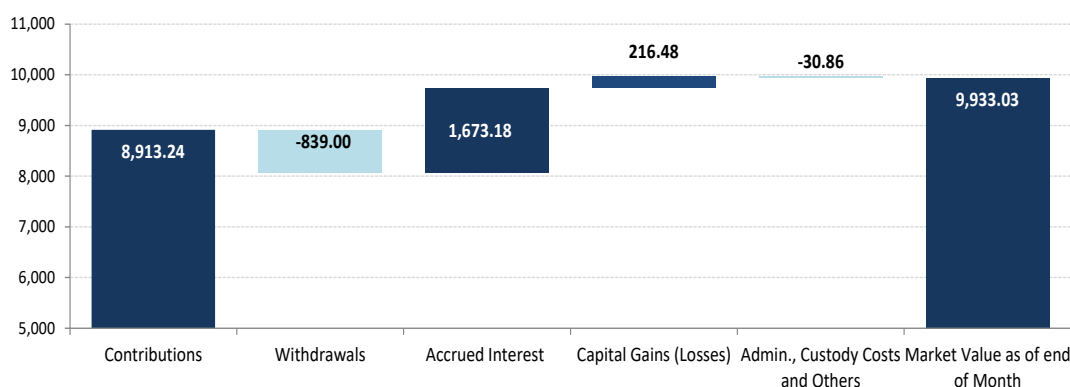
The market value of the Pension Reserve Fund (PRF) totaled US\$9,933.03 million at the end of the month. It changed due to: (i) accrued interests of US\$23.04 million, (ii) capital gains on investments of US\$247.53 million and (iii) administrative, custody and other costs of US\$0.78 million.

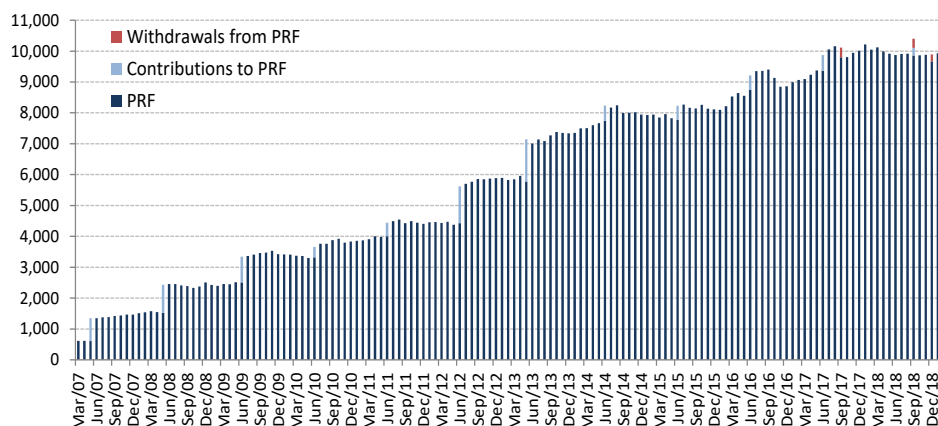

II. Return as of January, 2019

The monthly return in US dollars was 2.79%. For the Sovereign and Government Related Bonds the monthly return was 1.44%, for Inflation Indexed Sovereign Bonds 2.39%, for US Agencies MBS 0.66%, for Corporate Bonds, 2.26%, for High Yield Bonds 0.54%, and for Equities, 7.73%. The returns experienced by Sovereign and Government Related Bonds portfolio and the Inflation Indexed Sovereign Bonds portfolio were explained by the good performance in local currency and by the appreciation of the currencies in which the instruments are invested. Returns for Corporate Bonds, High Yield Bonds and Equities portfolios were mainly explained by the positive performance in local currency. Finally, the monthly return of the fund in pesos was -1.48%. Year to date return was 2.79% in US dollars and -1.48% in pesos, while the annualized return since inception was 3.44% in US dollars and 5.31% in pesos.

Returns for periods of more than one year are compound annualized rates while those for less than a year correspond to the change as seen in the stated period. With a view to meeting high standards of transparency and providing a better assessment of the gains or losses on investments, the Ministry of Finance discloses the fund's return in different time horizons and currencies. With respect to the horizon, it is important to note that, in keeping with the medium- and longterm investment policy, the return assessment should focus on that period, disregarding fluctuations that may occur monthly or quarterly. With regard to returns expressed in different currencies, the return in US dollars allows for an assessment which is more in line with the investment policy given that the fund's resources are wholly invested abroad and in foreign currency. The return in Chilean pesos is also disclosed. This return reflects changes in the peso-dollar exchange rate and, therefore, may experience greater fluctuations. Finally, as with any investment, returns obtained in the past do not guarantee future positive results.
