Monthly Executive Report as of April, 2018

I. Market Value as of April, 2018

The market value of the Pension Reserve Fund (PRF) totaled US\$9,990.96 million at the end of the month. It changed due to: (i) accrued interests of US\$16.71 million, (ii) capital loss on investments of US\$148.87 million and (iii) administrative, custody and other costs of US\$0.63 million.

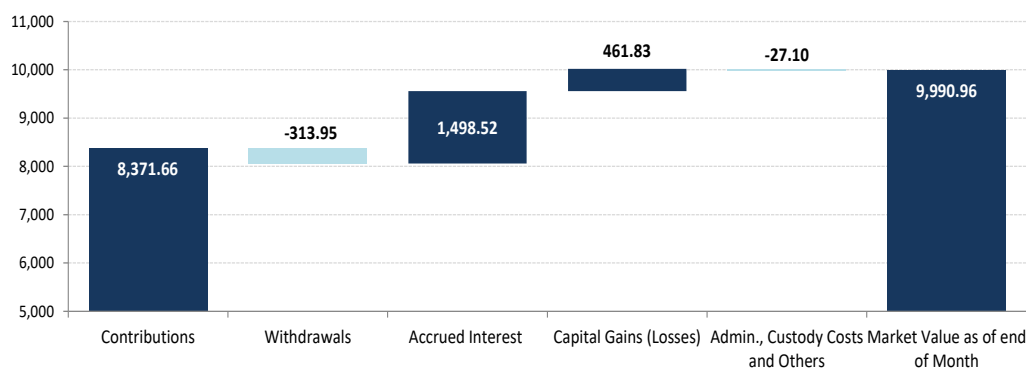

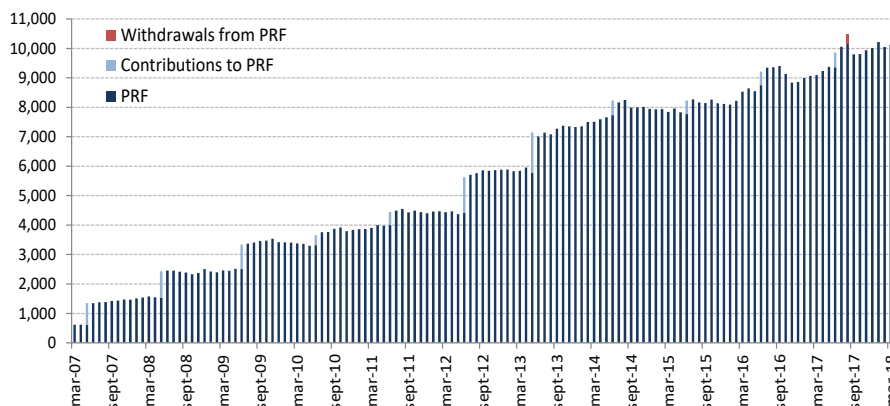

II. Return as of April, 2018

The monthly return in US dollars was -1.31%. This is decomposed in the return of the Sovereign and Government Related Bonds, -1.90%, Inflation Indexed Sovereign Bonds, -1.92%, Corporate Bonds, -1.10%, and Equities, -0.95%. By one hand, the return in US dollars experienced by both sovereign fixed income portfolio and corporated bonds portfolio was mainly explained by the appreciation of the US dollar againts the others currecies in wich the instruments are invested. Also, but in a lesser extent the negative performance was driven by the the negative return in local currency. On the other hand, the equity portfolio obtained a positive return, which is explained by the good result in the currency of origin of the instruments, which counteracted the negative efect driven by the exchange rate effect. In pesos, the monthly return of the fund was -1.23%. Finally, the fund accumulated during a year a return of 5.97% in dollars and a return of -3.37% in pesos, while the annualized return since inception was 3.74% and 4.83% respectively.

Returns for periods of more than one year are compound annualized rates while those for less than a year correspond to the change as seen in the stated period. With a view to meeting high standards of transparency and providing a better assessment of the gains or losses on investments, the Ministry of Finance discloses the fund's return in different time horizons and currencies. With respect to the horizon, it is important to note that, in keeping with the medium- and longterm investment policy, the return assessment should focus on that period, disregarding fluctuations that may occur monthly or quarterly. With regard to returns expressed in different currencies, the return in US dollars allows for an assessment which is more in line with the investment policy given that the fund's resources are wholly invested abroad and in foreign currency. The return in Chilean pesos is also disclosed. This return reflects changes in the peso-dollar exchange rate and, therefore, may experience greater fluctuations. Finally, as with any investment, returns obtained in the past do not guarantee future positive results.
