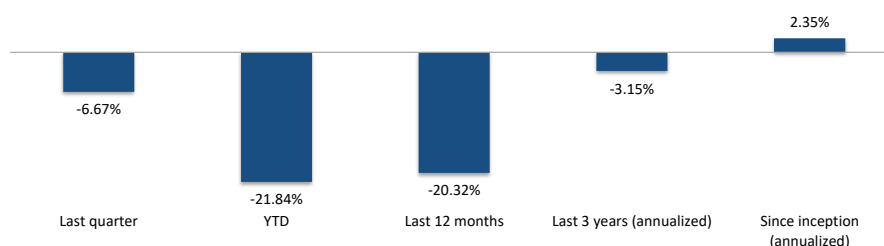

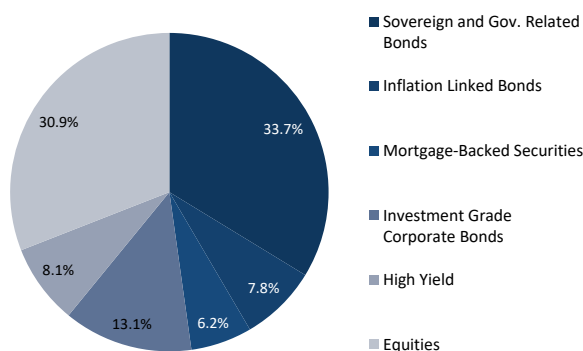

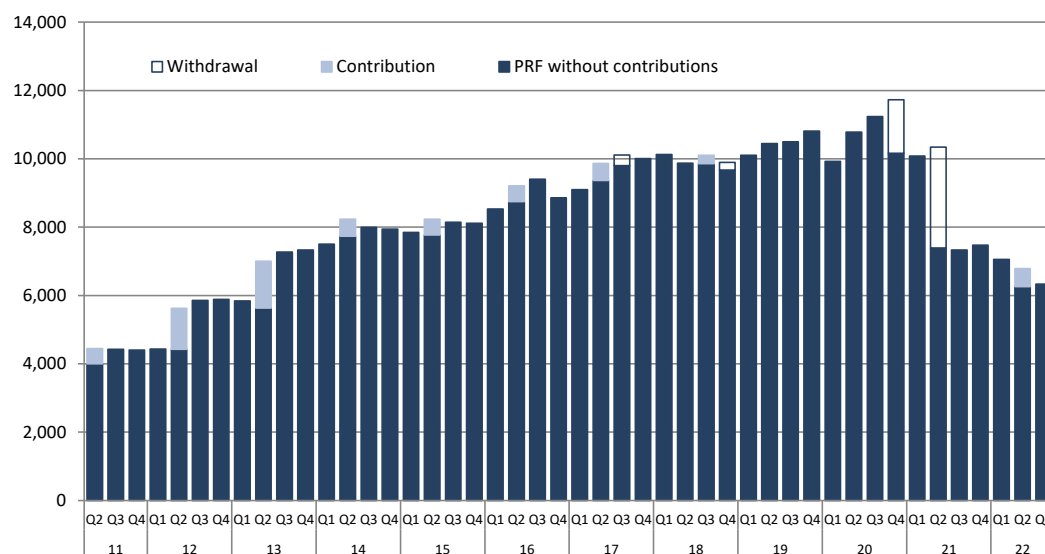

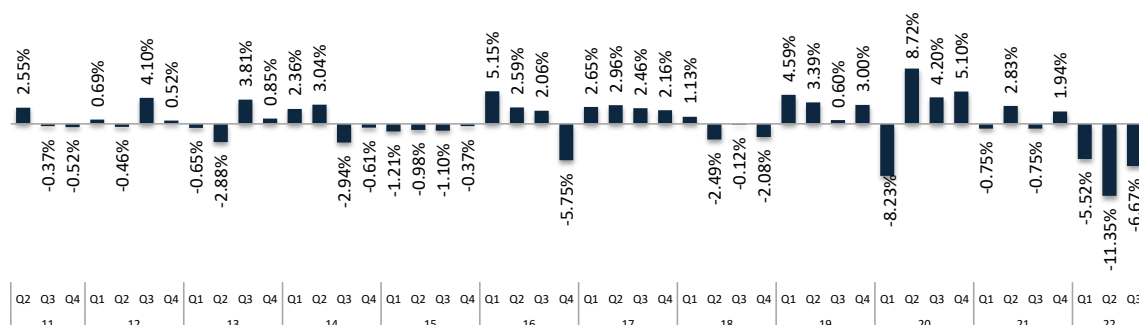

<sup>2</sup> The returns for periods of more than one year are compound annualized rates while those for less than a year correspond to the change as seen in the stated period. To meet high standards of transparency and provide a better assessment of the gains or losses on investments, the Ministry of Finance discloses the fund's return in different time horizons and currencies. With respect to the time horizon, it is important to note that, in keeping with the medium- and long-term investment policy, the return assessment should focus on that period, disregarding fluctuations that may occur monthly or quarterly. Regarding returns expressed in different currencies, the return in US dollars allows for an assessment which is more in line with the investment policy given that the fund's resources are wholly invested abroad and in foreign currencies. The return in Chilean pesos is also disclosed. This return reflects changes in the peso-dollar exchange rate and, therefore, may experience greater fluctuations. Finally, as with any investment, returns obtained in the past do not guarantee future positive results.

(percent)**



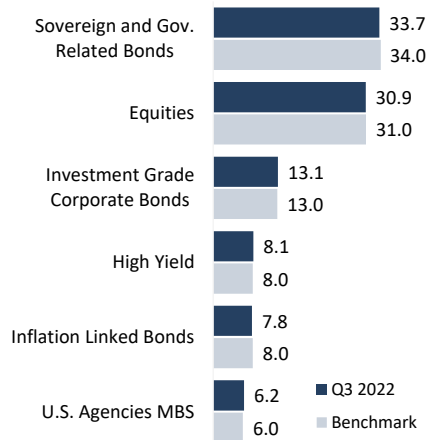

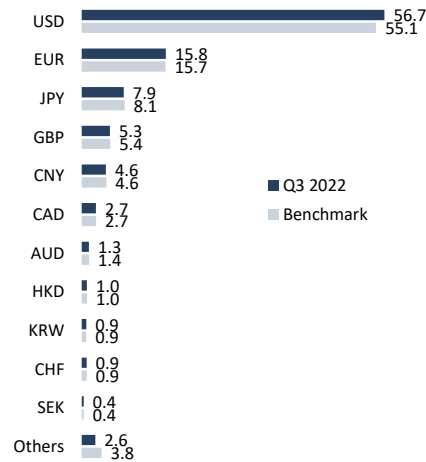

(percent of LTIP)



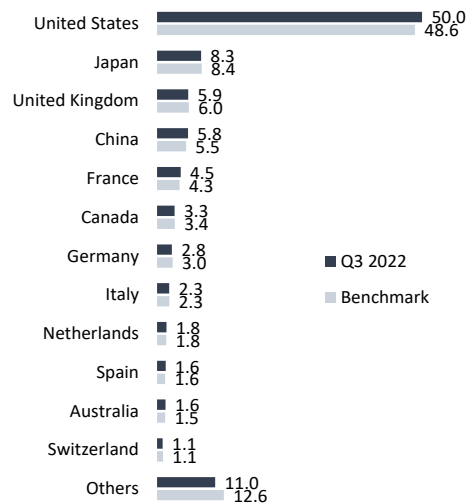

(percent of LTIP)



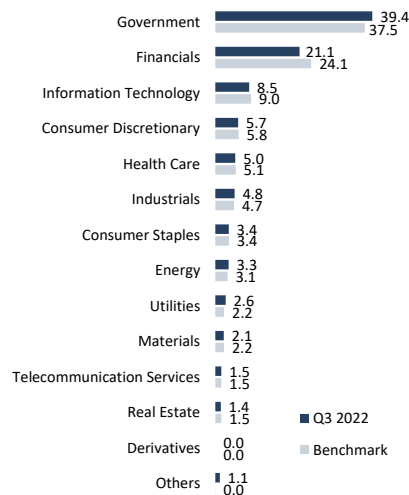

(percent of LTIP)

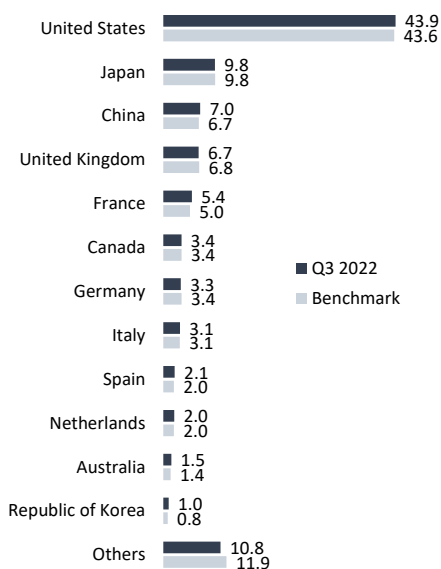

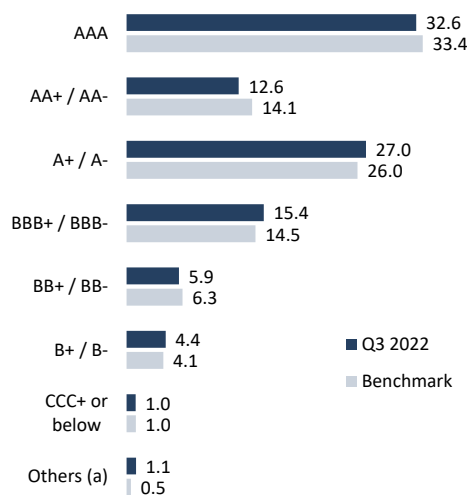

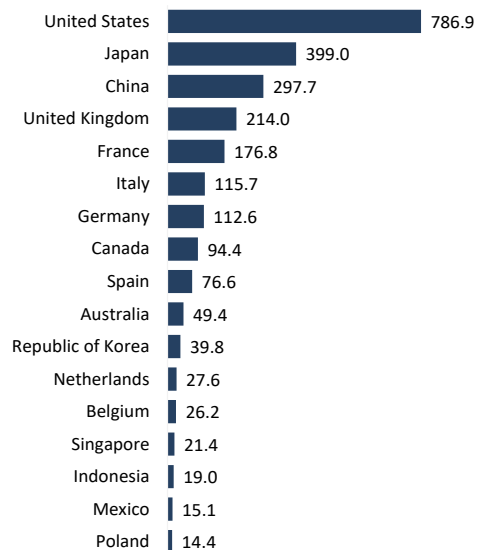

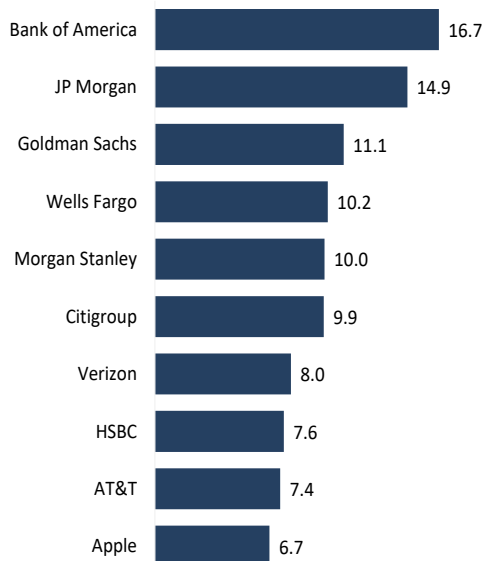

**Figure 10: Largest exposures to sovereign and Gov. Related bonds and inflation-indexed sovereign bonds (million of dollars)**



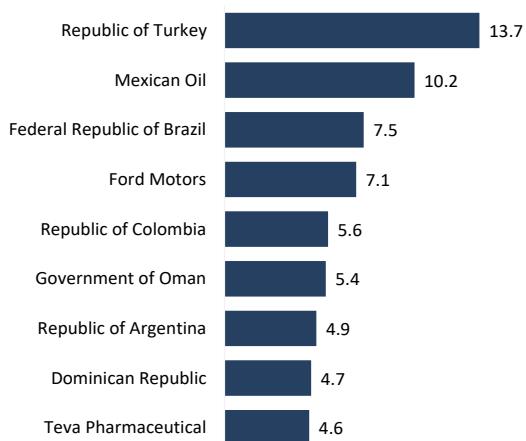

**Figure 11: Largest exposures to corporate bonds (million of dollars)**



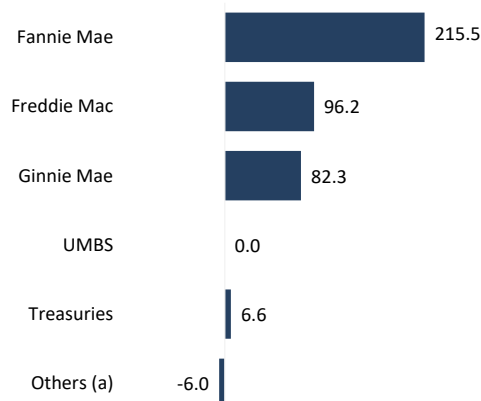

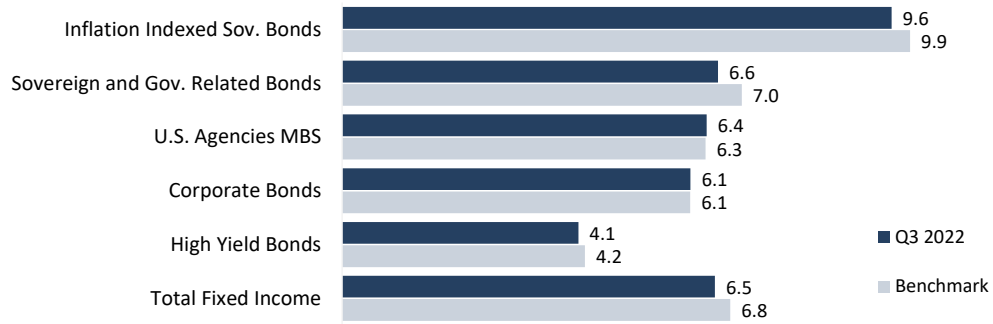
**Figure 13: Largest exposures to US Agencies MBS (million of dollars)**

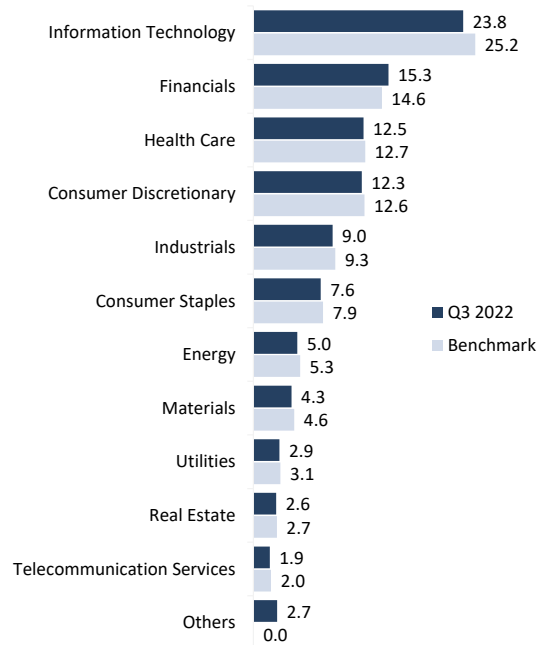

(percent of equity portfolio)



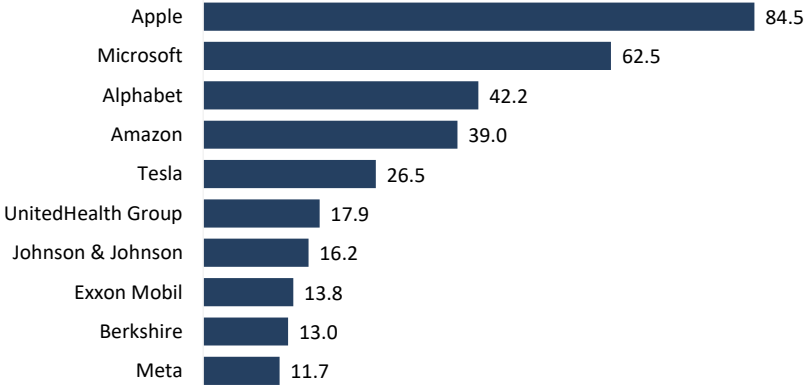

## IV. OTHER INDICATORS

An indicator commonly used for monitoring the market risk of the portfolio is the return volatility. In the quarter the standard deviation of returns of the PRF was 10.10%<sup>4</sup>. The tracking error ex-post, an indicator used to measure the degree of how close the portfolio tracks the return of benchmark, was 38 basis points<sup>5</sup> at the quarter end.

## V. SECURITIES LENDING INCOME AND ADMINISTRATION COST

The cost associated with the management of the fund by those responsible for the investment<sup>6</sup> was US\$ 814,552 during the quarter, while expenses associated with the custody service<sup>7</sup> were US\$ 588,785, and the cost associated to others<sup>8</sup> were US\$ 28,186. Meanwhile, the securities lending program generated revenues of US\$ 156,373 during the same period (see table 6).

<sup>6</sup> The Central Bank of Chile is responsible for the investment of the sovereign fixed-income portfolio (42% of the fund) and the US Agencies MBS portfolio (6% of the fund). In the case of the last, the administration is delegated to BNP Paribas and Western Asset Management. The investment of the equities portfolio (31%) is the responsibility of Mellon Capital Management Corporation and UBS Asset Management (UBS), while the investment of the corporate bonds portfolio (13%) is the responsibility of Credit Suisse and UBS, and the investment of the High Yield portfolio (8%) is the responsibility of Nomura Asset Management and BlackRock Institutional Trust Company. The entities responsible for investment portfolios of equities were selected in 2011 in the case of Mellon and 2020 in the case of UBS, and the corporate bond portfolio managers were selected at the end of 2020, while the entities responsible for investment portfolios of US Agencies MBS and High Yield bonds were selected at the beginning of 2019.
